Walmart+ x P&G BABY Livestream Giveaway Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Walmart+ x P&G BABY Livestream Giveaway (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Entrants who are minors must have permission from their parent or legal guardian to enter. 4. How to Enter: On February 24, 2022 at approximately 11:00 a.m. ET, Walmart will host a live shopping event on <u>Walmart.com/live</u>. Representatives of Sponsor will announce the Sweepstakes at the beginning of this live shopping event and provide a link to an online registration form ("Sweepstakes Registration form") within the live event chat. The live shopping event will conclude in approximately 1 hour. Entrants may visit the Sweepstakes Registration form and follow the instructions to complete and submit a valid email address during the Promotion Period. Upon completion of the registration form entrants will automatically receive one (1) entry into the Sweepstakes.

Entry Limit: You may enter one (1) time during the Promotion Period. Multiple entrants are not permitted to share the same email account. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different accounts, identities, registrations and logins, or any other methods will void that entrant's entry and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email account used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning the email address used to create the account. The potential winner may be required to show proof of being the authorized account holder. Released Parties (as defined in Section 7, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, un-intelligible, garbled, delayed, or misdirected Submissions or failure to receive Submissions due to limitation of third-party social network platforms all of which will be void.

5. Drawings: Administrator is an independent organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period, on or around February 28, 2022. The potential Sweepstakes winners will be notified by email. All winners will be directed to a secure online claim form and asked to provide their name, email address, mailing address, and date of birth to confirm eligibility and for prize fulfillment purposes within five (5) days of the date notice or attempted notice is sent in order to claim the prize. <u>For all Prizes</u>: Prize is non-transferable, and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize (or a component thereof) for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated

7. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the prizes offered herein.
